Identity Card of contractor/Managing partner/Director alongwith registered Power of Attorney and on payment of prescribed tender fee Rs.10000/- (Non-Refundable) in the form of CDR/Bank Draft in the favour of **Secretary BISE, Bahawalpur** of any scheduled Bank
3. Tendered rates and amount should be filled in figures as well as in words and tender should be signed as per General Directions given in the tender documents. No rebate on tendered rates will be acceptable.
4. Sealed tenders for the work will be received in the office of the undersigned on 18-01-2017 at 1:00 PM and will be opened on same day as per PPRA Rules 28 by the purchase/Tenders opening Committee B.I.S.E., Bahawalpur in the presence of intending contractor or their representatives.
5. Conditional tenders and tenders not accompanies with earnest money @ 2% of the Estimated Cost in shape of CDR / Bank Draft / Cashier's cheque of any scheduled bank in favour of **Secretary BISE, Bahawalpur** and attested copies of registered partnership deed and power of attorney in case of firms will not be entertained.

The lowest bidder whose bid will be less more than 5% of the estimated cost of the work will have to deposit the difference which will be returned on successful completion of the contract failure to deposit the difference within 15 days after the receipt of notice would result into forfeiture of earnest money.

 - i) The competent authority reserves the right to accept or reject all the tenders as per PPRA Rules 35. The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
